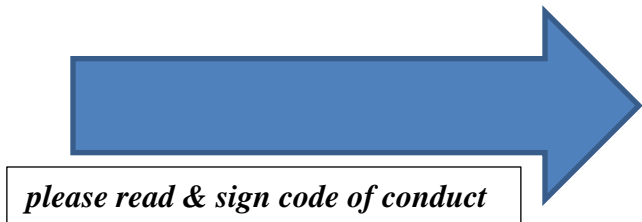

# **Borough of Lincoln Park Parks & Recreation Code of Conduct**

*The following is promulgated in accordance with the provisions of State of New Jersey P.L. 2002, Chapter 74*

Recreation and other youth programs play an important role in promoting the physical, social and emotional development of children. All participants, players, instructors, coaches, officials, parents, staff members, volunteers and other attendees who participate in or watch athletic programs, events or activities of the Recreation Department of the Borough of Lincoln Park, or who are playing or watching any athletic program, event or activity upon any public property owned by the Borough of Lincoln Park, shall be responsible for his or her own words and actions, and each such person shall conform his or her behavior to the following Code of Conduct.

***I therefore pledge to be responsible for my words and actions while participating, playing, instructing, coaching, officiating or participating in a Recreation Program or youth sport in any other way and shall conform my behavior to the following Code of Conduct.***

1. I will not engage in unsportsmanlike conduct with any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.
2. I will not encourage my child, or any other person, to engage in unsportsmanlike conduct with any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.
3. I will not engage in any behavior which would endanger the health, safety or well-being of any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.
4. I will not encourage my child, or any other person, to engage in any behavior which would endanger the health, safety or well-being of any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.
5. I will not use drugs or alcohol while at a youth sports event and will not attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
6. I will not permit my child, or encourage any other person, to use drugs or alcohol at a youth sports event and will not permit my child, or encourage any other person, to attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
7. I will not engage in the use of profanity.
8. I will not encourage my child, or any other person, to engage in the use of profanity.
9. I will treat any participants, players, instructors, coaches, officials, parents, staff members, volunteers and other attendees with respect regardless of race, creed, color, national origin, sex, sexual orientation or ability.
10. I will encourage my child to treat any participants, players, instructors, coaches, officials, parents, staff members, volunteers and other attendees with respect regardless of race, creed, color, national origin, sex, sexual orientation or ability.
11. I will not engage in verbal or physical threats or abuse aimed at any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees
12. I will not encourage my child, or any other person, to engage in verbal or physical threats or abuse aimed at any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.
13. I will not initiate a fight with any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees
14. I will not encourage my child, or any other person, to initiate a fight or scuffle with any participants, players, instructors, coaches, officials, parents, staff members, volunteers and/or other attendees.

***I hereby agree that if I fail to conform to the Borough of Lincoln Park Recreation Department's Athletic Code of Conduct, I will be subject to disciplinary action, including but not limited to the following listed below. I understand that penalties may be imposed in any order or in any combination.***

1. Verbal warning issued by the Recreation Department, PAL or other authorized Borough official.
2. Written warning issued by the Recreation Department, PAL or other authorized Borough official.
3. Suspension or immediate rejection from any Rec Program, activity or athletic event sponsored by the Rec Depart or PAL.
4. Season suspension or multiple season suspension issued by the Recreation Department, PAL or other authorized Borough official.
